I will serve with no expectation of compensation for my services or reimbursement for any expenditure which I incur for the care and treatment of my foster animal(s) without authorization. I understand that my Foster Care assignment may end at anytime without notice or cause and that the disposition of any animal(s) is at the sole discretion of Kitty Connection's management.

If, selected as a Foster Care Volunteer, I agree to abide by all of Kitty Connection's rules and regulations. This includes but is not limited to:

- Providing adequate food, water, shelter, exercise and kind treatment for the animal(s) at all times.
- Isolating the animal(s) upon receiving them into my care to minimize possibility of my own animal(s) becoming ill.
- A reasonable, continuing effort to monitor the animal(s) to assure proper health so that their possibility for adoption once returned to Kitty Connection is maximized.
- If the Foster Animal becomes Ill or is Injured you agree to bring it to Kitty Connection in Medford or Revere Pet Clinic in Revere for treatment.

I give Kitty Connection's Board of Directors permission to investigate all pertinent information and references concerning my Foster Care Volunteer application. I hereby release said employers, companies, schools, or persons from all liability *for* any damage, both legal and otherwise for issuing information.

If selected as a Foster Care Volunteer, I agree to maintain the confidentiality of all proprietary or privileged information of Kitty Connection to which exposed while serving as a volunteer, whether this information involves a single staff, volunteer, client, animal, or other person or involves overall Kitty Connection's business. I also acknowledge that failure to maintain confidentiality would be cause for dismissal from the volunteer program with Kitty Connection.

I certify that all information that I have provided on this application is true and complete to the best of my knowledge. Any misrepresentation, or omission of facts called for in this application may result in rejection of my application as a volunteer or dismissal from the Volunteer program.

## **Foster Care Volunteer Release and Waiver**

Please read the following statements; they constitute the conditions under which you would be volunteering with Kitty Connection should you be accepted as a Foster Care Volunteer. Please note that the Foster Care Volunteer program is highly competitive and that this is an application and is not a guarantee of placement.

### **Release**

In consideration of my acceptance as a Kitty Connection Foster Care Volunteer, my signature below indicates that I have read, understand, and agree to the following:

I acknowledge and have been advised of certain communicable diseases that can be contracted from interaction with animals, and safety precautions to prevent contracting such communicable diseases. Such diseases principally include, but are not limited to, Rabies, Cat Fever, Hepatitis, Hookworm, Ringworm, Intestinal Worms, Mites, and Mange. I acknowledge and have been advised of the risk of injury from interacting with animals, including bites, and scratches, or other injuries from animals, and agree to report any such injury immediately to my supervisor.

I authorize Kitty Connection to seek emergency medical treatment for me in case of an accident, injury, or illness. I agree to abide by all policies and procedures of Kitty Connection. I hereby agree to release, indemnify and hold harmless Kitty Connection, its directors, officers, employees, and agents from any and all claims, damages, and liability, including, but not limited to, any loss or injury to me and/or my personal property arising from or related to my activities as a Kitty Connection Volunteer under this agreement or for any negligent act or omission by the Kitty Connection, its directors, officers, employees, and agents. In connection with my activities as an Kitty Connection Volunteer, I further agree to release, hold harmless and indemnify the Kitty Connection, its directors, officers, employees and agents, from any and all claims, damages and liability, including, but not limited to, any loss or injury to me and/or my personal property arising from my riding as a passenger in any motor vehicle owned or leased by Kitty Connection and operated by an employee or authorized agent of Kitty Connection.

Kitty Connection retains ownership of all cats/kittens in the care of foster homes. Upon written request, all cats/kittens shall be returned to Kitty Connection. The foster home provider shall be responsible for all legal and all other fees resulting in Kitty Connections efforts to reacquire said cat/kitten to Kitty Connection's possession.

I, the below named Volunteer, understand that Kitty Connection, Inc. and its representatives have limited information regarding the temperament and habits of the animals under its care and ownership. As a Volunteer for Kitty Connection, Inc., I agree to take all reasonable precautions (through the use of crates, supervision and common sense) to ensure that the animal does not get out of the house, become a nuisance, destroy property, injure or be injured by another animal, be injured by any person, or injure me or another person.

By becoming a Volunteer, I hereby waive, release, discharge and hold harmless Kitty Connection, Inc. and its agents, employees, directors, representatives and other volunteers charged or chargeable with liability, from any and all claims, damages, costs, expenses, loss of services, actions, and causes of actions, whether known or unknown, belonging to me, my heirs, agents and assigns, due to any action or occurrence or damage which arises in connection with my volunteer activities, including, but not limited to cat bites to me or members of my household by a Kitty Connection, Inc. animal.

I understand that once I take a Kitty Connection, Inc. cat in for foster that I am making a commitment to the animal until it is placed into an adoptive home. I will give Kitty Connection, Inc. proper notice should I not be able to continue fostering so that further suitable placement can be found for the animal. If I need the cat immediately removed from my care through no fault of the cat (aggression, biting, etc.), I agree that I will be financially responsible for boarding the cat until another suitable placement can be found.

Furthermore, I agree to indemnify Kitty Connection, Inc. for any and all expenses, including court costs and reasonable attorney fees, incurred in enforcing the terms and provisions of this agreement.
